Please Comment On The Controversial Land Expropriation Without Compensation Policy!

The Constitutional Review Committee - mandated by Parliament - released an invitation for public submissions on the review of section 25 of the Constitution and other sections to make it possible for the state to expropriate land (in the public interest) without compensation.

The invitation says, “As part of exercising the constitutional obligation to facilitate public participation, the (Constitutional Review) Committee invites written submissions from all stakeholders on the necessity of, and mechanisms for expropriating land without compensation.”

What this means is government wants to know your views on its proposal to amend the Constitution so the State can seize privately owned land without compensating the land owner.

This is a controversial and dangerous policy that will undoubtedly provoke more conflict. There are better ways of solving the land issues in South Africa than state sanctioned land grabs.

The one thing citizens have learned over the past decade is the ANC ruled government does very little in the interest of the people. Most of what government does benefits the ANC first. As a result, South Africa suffered years of political chaos and brought to the brink of economic collapse.

Most State Owned Enterprises were crippled because the ANC deployed its cadres in key positions to protect its own interest – not the interest of the people of South Africa.

So too were positions filled by loyal ANC cadres in the SAPS, Hawks, NPA, Public Protectors Office, State Security Agency etc. As a result, crime and corruption flourishes in South Africa.

I am not convinced the state will expropriate land without compensation in the public interest. It will do so in the ruling party’s interest and perhaps to appease the rabid racism of Julius Malema and his EFF whose main policy objective appears to be [“cutting the throat of whiteness.”](#)

Once the Constitution is amended nothing stops the government from using land expropriation without compensation as a blunt instrument to punish its political foes.

If we have learned anything from the Jacob Zuma presidency, it is that the ANC ruled

government will do whatever it takes to remain in power and that includes brazen acts of criminality.

The Christian Church is also vulnerable under this policy. Church land can be expropriated without compensation for any number of reasons. The Church is often the target of corrupt regimes.

Widespread land invasions were triggered by government's announcement of land expropriation without compensation. Many believe the [land invasions are orchestrated by certain groups](#).
