### ***EFF Proposes No Private Land Ownership In South Africa! State Must Own All Land!***

The Ad-Hoc Committee considering the review of section 25 of the Constitution to provide government the legal right to expropriate private land without compensation has [extended the deadline](#) for written submissions to 15 June. No further extensions will be granted.

Apparently, the Constitutional Review Committee has already received 140,000 submissions from the public or organisations. Many, however, are multiple copies of the same submission.

Form letters or hundreds of people signing one submission does not work. It's regarded as one submission regardless of the number of signatories. The Committee will consider individual written submissions from citizens. You may also apply to make oral submissions in hearings.

During a recent TV interview with ACDP President, Rev Kenneth Meshoe I was surprised to learn the EFF's real intention for amending section 25 of the Constitution to expropriate land.

Clause 10 (b) of the EFF Motion reads, (The EFF) “Propose the necessary constitutional amendments with regards to the kind of future land tenure regime needed, taking into account the necessity of the State being a custodian of all South African land.”

Consequently, the EFF propose the State expropriate all land from citizens and private organisations without compensation and become the custodian of all land in the country.

Rev Meshoe also refers to the [EFF's “Policy on Land Expropriation.”](#) In it the policy document declares, all land must be expropriated from all citizens – black and white – without compensation. The State as the “custodian” of all land in South Africa must then lease land to private individuals or corporations for a maximum (renewable) period of twenty-five years.

Alarminglly, the EFF's Motion on Land Expropriation was adopted on 27 February 2018 supported by the EFF, ANC and IFP. The ACDP, DA, Freedom Front Plus and Cope voted against it.

In light of this revelation, the implications of amending section 25 of the Constitution to give government the right to expropriate privately owned land without

compensation, are dire.

The ANC, who lost much support because of rampant corruption and gross mismanagement of state resources, adopted the radical EFF policy in a desperate attempt to restore its popularity.
